Description: Scavenger™ II Head Type 17 QuickGrab™ Point UltraCut Thread™ with DrawTite™ Upper Threads screw used in wood-to-wood applications.

Directions: Use a standard screwgun with a depth sensitive nose piece. Suggested screwgun specification for optimal performance - Gauges #6 to #10, up to 4,000 RPM. The head is fully seated when the head is flush with the work surface. Overdriving may result in failure of the fastener.

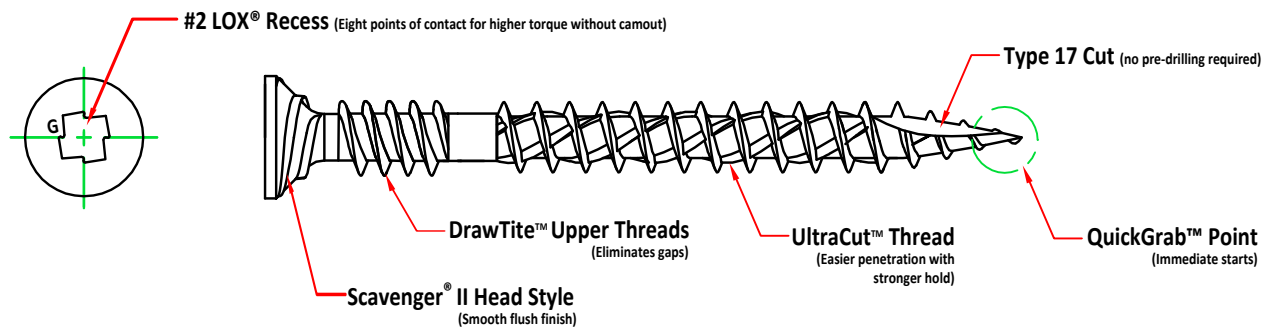
